Indication of immediate medical attention and special treatment needed, if necessary

- Notes to physician** : Treat symptomatically. Contact poison treatment specialist immediately if large quantities have been ingested or inhaled. - Specific treatments** : Under controlled feeding conditions, urea is used as a nutritional supplement in cattle and other animals. The toxic dose in cattle given urea for the first time is considered to be 0.45 g/kg or a total of 100-200 g. Mature bulls can digest as much as 400 grams per day without ill effects. As little as 50 g may cause adverse effects in cattle not accustomed to it.

Animal Antidote and Emergency Treatment:

In animals, the cold water - acetic acid treatment may work. The adult cow is given 19-38 liters cold water and 3.8 liters of 5% acetic acid (vinegar) orally. This treatment limits absorption of ammonia from the rumen by diluting the rumen contents and slowing the rate of hydrolysis of urea by decreasing rumen pH and temperature. The treatment also promotes urine flow that, if maintained by fluid therapy, may assure recovery from urea toxicity. Gaseous or fluid bloat should be relieved before pumping water into the rumen. Consult your veterinarian immediately.
